RULES & REGULATIONS / EXHIBITOR INFORMATION

All questions not covered in these rules & regulations shall be decided by the show management whose decision shall be final.

1. Pre-Entries close the Wednesday prior to the show at 9:00 P.M. Please pre-enter! Online: www.Horseshowing.com Email: horseshow@kimbertonhunt.org Fax: 610.469.6847 Mail: Mrs. Barbara Dunn, 1030 Jaine Lane, Chester Springs PA 19425. Post entries will be accepted and will incur a \$25.00 post entry fee. Complete your entry blank with correct USEF/USHJA number for owner, rider, trainer and horse with the required signatures and bring any relevant documentation to the show. Incomplete or illegible entries will incur a post entry fee. (i.e. please do not use "same" when completing entry) No charge for Scratch/Additions done with the office. NO PHONE ENTRIES. All entries not paid at the horse show will incur a \$50.00 late payment fee. All returned checks will incur a \$25 fee.

2. A \$25.00 fee will be charged to all entries to cover EMT/Office & Grounds fees. (Lead Line exempt)

3. If applicable, leave a signed open check made payable to "Kimberton Hunt Club" with your completed & signed entry at the show office.

4. All fees are \$25 per class unless otherwise noted. 8 Ribbons unless otherwise noted.

5. A current negative Coggins and a Health Record must accompany your entry at the show office.

6. To be eligible for a Stake class, the exhibitor must show in at least one other over fence class in the same division.

7. For all sanctioned classes other than USEF pointed classes such as M&S/PHSA, horse and rider combination must enter at least one other class at the show. It is the exhibitor's responsibility to know their eligibility to compete in any class at this show.

8. In order to compete in any recognized USEF/USHJA class, rider/owner/trainer must be a member or pay the Show Pass fee(s). USEF Show Pass: \$45. USHJA Show Pass: \$30. Outreach & Opportunity classes are exempt from USEF/USHJA membership fees. Outreach entries must use the "Outreach" entry blank. If Outreach & Opportunity Riders and/or Horses cross enter into rated/recognized classes, all fees will apply. A \$23 Federation Fee will be collected (which includes a \$15 Equine Drugs & Medication fee) Exception: horses entered in classes exempted from the Drugs & Medication Fee are also exempt from the balance of the Federation Fee.

9. All prize money will be issued at the show. Checks must be cashed within 30 days or they will not be honored.

10. No refunds on prize \$ classes once the order of go has been established or division has started.

11. Hunter courses may include gates, walls, brush, coop, post and rail, oxers, in and outs, and combinations. Jumper courses may include verticals, oxers, panels, gates, spreads, combinations.

12. Hunters will be judged on performance, soundness and manners.
13. A jump order will be established at the gate with the starter.
14. All ties, other than first will be broken by time.
15. Every horse entered for competition will comply with the rules of the horse show management. The Kimberton Hunt Club, The Horse Show, The Show Committee will not be held responsible for any loss, damage or accident that may occur to any rider, driver, groom, coach, trainer, attendant, animal or equipment at the show. It shall be a condition of entry that each exhibitor shall hold the Hunt Club, the Horse Show & Committee, its members, directors, employees, contractors, sponsoring entities and the facility harmless for any loss or accident to horse, human or equipment, which may occur.
16. The Committee/Management reserves the right to cancel/combine, move or substitute classes at their discretion; to change any course; to change rings or judges; to add a mandatory (dotted) line; to change specifications in jumper classes in order to facilitate the time schedule or as competition warrants. Exhibitors must advise the in-gate of any conflicts. Under Saddle classes will not be held due to trainer conflict. Please be ready for your class.
17. Exhibitors are notified that any act of discourtesy or disobedience to the judges, officials or volunteers on the part of any owner, rider, trainer, coach, groom or family member may disqualify the horse, and the owner shall forfeit all entry and other fees.
18. It is the tradition of the show that riders be correctly attired for the class in question, that attendants be neatly dressed and the horses properly presented. Management may in its discretion bar any person from entering the ring if not suitably presented to appear before an audience.
19. Schooling: A Blue/Red Warm Up class replaces schooling in the show ring unless otherwise noted on the schedule. Hacking only in the main ring before the show. Jumpers do one course walk before the division. Schooling will be permitted only in areas provided by the committee.
20. Every class offered herein which is covered by the rules and specifications of the current USEF Rule Book, USHJA Zone 2, and points affiliates will be conducted and judged in accordance therewith.
21. Every entry at a Licensed Competition constitutes an agreement that the person making it, owner, lessee, trainer, manager, agent, coach, driver, rider, handler, vaulter, longeur, and the horse are subject to the Bylaws and the rules of the Federation and the local rules of the competition. Every exhibitor, rider, driver, handler, vaulter, longeur, coach and trainer or his/her agent(s) must sign an entry blank. In the case of a rider, driver, handler, vaulter or longeur under the age of 18, his/her parent or guardian, or if not available, the trainer, must sign an entry blank on the minor's behalf. If any of the above persons fails to do so his/her first entrance into the ring as an exhibitor, rider, driver, handler, vaulter or longeur shall be construed as his/her acceptance of the rules of the competition involved and of the Federation and shall ipso facto render him/her subject to said rules.
22. All pets must be kept on a leash.

23. Sharps containers will be located at the show office.

24. Measurements will be done approximately 9:00 AM – 12:00 PM day of show with the Steward and on-call veterinarian. Please schedule your measurement in advance by calling 610.469.0227 or email horseshow@kimbertonhunt.org

25. Horses/Ponies competing in classes requiring USHJA horse registration must be microchip compliant. Outreach classes exempt.

27. Ring 1: 100'x310' sand Ring 2: 150'x270' sand Ring 3: 160'x300' sand. Schooling ring: 100' x 200' sand

28. USEF MOTORIZED VEHICLE STATEMENT: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

29. USEF MEMBERSHIP STATEMENT: Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR218) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding Classes

Thoroughbred Incentive Program

General Information & Links

To encourage the retraining of Thoroughbreds into other disciplines upon completion of careers in racing or breeding, The Jockey Club created the Thoroughbred Incentive Program (T.I.P.). T.I.P. offers sponsorship for Thoroughbred-only classes and divisions, high point Thoroughbred awards at open horse shows and competitions, self-reported year end Performance Awards, a Recreational Riding Incentive Program, a Thoroughbred of the Year Award, a Youth Ambassador Program and a Young Rider of the Year Award.

T.I.P. Numbers - For purposes of eligibility for all T.I.P. classes and awards, a "Thoroughbred" is defined as any horse that has been registered with The Jockey Club or a foreign Thoroughbred stud book recognized by The Jockey Club. To participate in T.I.P., owners and riders must obtain a T.I.P. Number. To apply for a T.I.P. number, please visit tjctip.com and click on "My Account". You will need an Interactive Registration™ account to apply for a T.I.P. Number. Interactive Registration™ is a FREE service designed for the use of thoroughbred owners and breeders to transact business electronically with The Jockey Club registry. T.I.P. Numbers are free. The T.I.P. number card should be provided to participating horse shows as proof of eligibility.

T.I.P. has a number of programs geared toward all riders and Thoroughbreds. Generally, all information on T.I.P. programs can be found on our website (tjctip.com) under "TB Owners & Riders".

Horse Show Awards – T.I.P. offers sponsorship of Thoroughbred classes and high point awards at approved horse shows in virtually all disciplines, including hunter/jumper, eventing, dressage, Western, polo, polocrosse, and endurance. A list of approved horse shows is available at tjctip.com (see Calendar of Events).

Performance Awards – The Performance Awards are T.I.P.'s year end, self-reported Thoroughbred "points program". The Performance Awards are completely self-reported by the Thoroughbred's owner or rider. The Award Year is December 1 - November 30 and all forms are due December 20.

Recreational Riding Program – The Thoroughbred Recreational Riding Incentive Program (TRRIP) is designed to recognize and reward Thoroughbred owners and riders that enjoy recreational riding or driving on a regular basis. There are prizes associated with each hour level, beginning with 25 hours.
